

Held JANUARY 19 20 16

Council met in regular session at 7:00 P.M. in council chambers at city hall, 28 W. Friend Street, Columbiana, Ohio 44408 with Mayor Bryan Blakeman presiding. Clerk of Council Deann L. Davis gave the invocation. Blakeman led the pledge of allegiance to the flag of the United States of America.

Also answering roll call were City Manager Lance Willard and Municipal Attorney Daniel A. Blasdell. Council member Dan Bekar was absent.

Each member of council had a copy of the agenda for this regular council meeting.

Each member of council had a copy of the minutes of the regular council meeting held on January 5, 2016. The minutes stand as presented.

Each member of council had a copy of the Columbiana City Planning Commission meeting minutes of January 12, 2016.

Willard presented council members with the manager's update and the building/zoning department reports for October, November, and December 2015; the mayor's court report for December 2015; and the 4th quarter 2015 building/zoning department report.

McBane moved to concur with the city manager and chief of police to appoint Nathan Bachman to the Columbiana Auxiliary Police Force. Souder seconded the motion and on roll call: Souder, yea; McBane, yea; Liston, yea; Boggs, yea; and Noel, yea. (Motion Passed.)

Blasdell administered the oath of office to Bachman.

Council members reviewed the bill list of January 19, 2016.

Blakeman noted under old business there was one resolution and two ordinances and under new business there was one ordinance. Liston moved that, due to the length of the ordinances and resolution, and because each member of council had a copy in his or her possession, Blakeman read the ordinances and resolution by title only. Boggs seconded the motion and on roll call: McBane, yea; Liston, yea; Boggs, yea; Noel, yea; and Souder, yea. (Motion Passed.)

Blakeman read Resolution 16-R-488 by title only-----

"A RESOLUTION ACCEPTING MONIES FROM THE COLUMBIANA COUNTY BOARD OF COMMISSIONERS TO BE USED EXCLUSIVELY FOR WAGES AND RELATED BENEFITS TO PERMIT THE CITY OF COLUMBIANA POLICE DEPARTMENT TO ASSIGN AN OFFICER TO THE COLUMBIANA COUNTY DRUG TASK FORCE."

McBane moved to approve Resolution 16-R-488 under SECOND READING. Noel seconded the motion and on roll call: Liston, yea; Boggs, yea; Noel, yea; Souder, yea; and McBane, yea. (Motion Passed.)

Blakeman read Ordinance 16-O-2851 by title only-----

"AN ORDINANCE AUTHORIZING THE SALE OR RECYCLING OF PERSONAL PROPERTY WHICH IS NO LONGER NEEDED FOR MUNICIPAL PURPOSES."

Souder moved to approve Ordinance 16-O-2851 under SECOND READING. Liston seconded the motion and on roll call: Boggs, yea; Noel, yea; Souder, yea; McBane, yea; and Liston, yea. (Motion Passed.)

Blakeman read Ordinance 16-O-2852 by title only-----

"AN ORDINANCE REJECTING THE ANNEXATION OF CERTAIN TERRITORY CONTAINING 183.746 ACRES OF LAND IN FAIRFIELD TOWNSHIP, COLUMBIANA COUNTY, OHIO TO THE CITY OF COLUMBIANA."

Souder moved to approve Ordinance 16-O-2852 under SECOND READING. McBane seconded the motion and on roll call: Noel, yea; Souder, yea; McBane, yea; Liston, yea; and Boggs, yea. (Motion Passed.)

Boggs moved to concur with the mayor's appointment of David Barbee, Rich Hura, Connie Witt, Monica Robb, and Nicole Ice to the Charter Review Commission. Liston seconded the motion and on roll call: Souder, yea; McBane, yea; Liston, yea; Boggs, yea; and Noel, yea. (Motion Passed.)

Blakeman read Ordinance 16-O-2854 by title only-----

"AN ORDINANCE AMENDING SECTION 678.09(d) OF THE CODIFIED ORDINANCES OF THE CITY OF COLUMBIANA, OHIO."

McBane moved to approve Ordinance 16-O-2854 under FIRST READING. Noel seconded the motion and on roll call: McBane, yea; Liston, yea; Boggs, yea; Noel, yea; and Souder, yea. (Motion Passed.)
