McBane read Resolution 16-R-492 by title only-----
"A RESOLUTION AUTHORIZING THE CITY MANAGER TO FILE AN APPLICATION WITH THE DARE GRANTS OFFICE OF THE ATTORNEY GENERAL'S OFFICE FOR FUNDING ASSISTANCE OF THE D.A.R.E. PROGRAM"

Liston moved to approve Resolution 16-R-492 under SECOND READING. Boggs seconded the motion and on roll call: McBane, yea; Liston, yea; Boggs, yea; Noel, yea; and Souder, yea. (Motion Passed.)

McBane noted Ordinance 16-O-2871 was an emergency. Souder moved to suspend the rule requiring an ordinance or resolution be read at two separate meeting dates of council for the purpose of an emergency. Liston seconded the motion and on roll call: Liston, yea; Boggs, yea; Noel, yea; Souder, yea; and McBane, yea. (Motion Passed.)
