

Held JULY 19 20 16

Council met in regular session at 7:00 P.M. in council chambers at city hall, 28 W. Friend Street, Columbiana, Ohio 44408 with Mayor Bryan Blakeman presiding. Clerk of Council Deann L. Davis gave the invocation. Blakeman led the pledge of allegiance to the flag of the United States of America.

Each member of council had a copy of the agenda for this regular council meeting.

Boggs moved to amend the minutes of the June 7, 2016 meeting. McBane seconded the motion and on roll call: Bekar, yea; Souder, nay; McBane, yea; Liston, nay; Boggs, yea; and Noel, yea. (Motion Passed.)

Each member of council had a copy of the minutes of the regular council meeting held on June 21, 2016. Liston moved to amend the minutes. Boggs seconded the motion and on roll call: Souder, yea; McBane, yea; Liston, yea; Boggs, yea; Noel, yea; and Bekar, yea. (Motion Passed.)

Each member of council had a copy of the Columbiana Park, Recreation, and Cemetery Board meeting minutes of June 27, 2016; and the Columbiana City Planning Commission meeting minutes of July 12, 2016.

Lance Newton of Arrow Disposal appeared before council. Discussion followed regarding garbage hauling and curbside recycling.

Robert Merkel of 420 Quincy Avenue appeared before council to request that water used for outside purposes be charged for the water rate only and not the sewer rate.

Shari Frye of 347 South Main Street appeared before council to express her opposition to an outdoor gun range on Industrial Drive and to inform council that Attorney Brian Macala represents her.

Attorney Brian Macala of South Lincoln Avenue in Salem appeared before council and stated he will take action on Frye's behalf if council changes the code to allow the outdoor gun range on Industrial Drive.

Joan Clunen, Glenda Ledbetter, and Terry Setinsek of Southern Terrace appeared before council to express their concerns about the outdoor gun range. Clunen presented a petition to Blakeman.

Blakeman and McBane stated council took no action to change the code to allow the outdoor gun range.

Don Plant of Southern Terrace appeared before council regarding gun fire at homes next to Southern Terrace. Police Chief Tim Gladis stated the homes are not in the city limits.

Jake Sevek of Fairfield School Road appeared before council and expressed his concern about the fear invoked by the people opposed to the gun range.

Jake Kellner of 321 Industrial Drive invited anyone with questions to stop at his shop.

Willard presented council members with the manager's update.

Willard presented council members with the EMS department report for June 2016.

Willard presented council members with the bid results for the water treatment plant project.

Council members reviewed the bill lists of July 5 and July 19, 2016.

Blakeman noted under old business there were two resolutions and two ordinances and under new business there was one ordinance.

Liston moved that, due to the length of the resolutions and ordinances, and because each member of council had a copy in his or her possession, Blakeman read the resolutions and ordinances by title only. Noel seconded the motion and on roll call: McBane, yea; Liston, yea; Boggs, yea; Noel, yea; Bekar, yea; and Souder, yea. (Motion Passed.)
