Held JANUARY 17 2017

Council met in regular session at 7:00 P.M. in council chambers at city hall, 28 W. Friend Street, Columbiana, Ohio 44408 with Council President Richard McBane presiding. Clerk of Council Deann L. Davis gave the invocation. Boy Scout Troop 40 led the pledge of allegiance to the flag of the United States of America.

Also answering roll call was City Manager Lance Willard. Mayor Bryan Blakeman and Municipal Attorney Daniel A. Blasdell were absent.

Each member of council had a copy of the agenda for this regular council meeting.

Each member of council had a copy of the minutes of the regular council meeting held on January 3, 2017. The minutes stand as presented.

Council members received a copy of the Columbiana Planning Commission special meeting minutes of December 30, 2016; the Park, Recreation, and Cemetery Board meeting minutes of December 19, 2016; the Columbiana Planning Commission meeting minutes of January 10, 2017; and the Columbiana Board of Zoning Appeals meeting minutes of January 12, 2017.

Liston moved to ask the planning commission to formulate reasonable conditions to allow city residents to have chickens. Boggs seconded the motion. Discussion followed.

On roll call: Bekar, nay; Souder, yea; McBane, yea; Liston, yea; Boggs, yea; and Noel, nay. (Motion Passed.)

Linda VanDyke, a Columbiana resident, and Colleen Campbell of 562 East Park Avenue stated they feel residents of the city should be allowed to have chickens.

Willard presented council members with the manager's update.

Willard presented council members with the mayor's court report for December 2016.

Noel moved to concur with the city manager and chief of police to appoint John Mann to the auxiliary police force for the City of Columbiana. Bekar seconded the motion and on roll call: Souder, yea; McBane, yea; Liston, yea; Boggs, yea; Noel, yea; and Bekar, yea. (Motion Passed.)

Council members reviewed the bill list of January 17, 2017.

McBane noted under old business there were two ordinances and under new business there was one ordinance. Souder moved that, due to the length of the ordinances, and because each member of council had a copy in his or her possession, McBane read the ordinances by title only. Liston seconded the motion and on roll call: McBane, yea; Liston, yea; Boggs, yea; Noel, yea; Bekar, yea; and Souder, yea. (Motion Passed.)

McBane read Ordinance 17-O-2897 by title only-----  
"AN ORDINANCE ESTABLISHING A WAGE SCHEDULE FOR CERTAIN FULL-TIME AND PART-TIME EMPLOYEES OF THE CITY OF COLUMBIANA."

Souder moved to approve Ordinance 17-O-2897 under SECOND READING. Noel seconded the motion and on roll call: Liston, yea; Boggs, yea; Noel, yea; Bekar, yea; Souder, yea; and McBane, yea. (Motion Passed.)

McBane read Ordinance 17-O-2898 by title only-----  
"AN ORDINANCE PROHIBITING MEDICAL MARIJUANA CULTIVATION, PROCESSORS AND RETAIL DISPENSARIES WITHIN THE CITY OF COLUMBIANA."

Bekar moved to approve Ordinance 17-O-2898 under SECOND READING. Souder seconded the motion. Boggs stated she read the medical marijuana regulations and she is not opposed to medical marijuana businesses in the city.

On roll call: Boggs, nay; Noel, yea; Bekar, yea; Souder, yea; McBane, yea; and Liston, yea. (Motion Passed.)

McBane noted Ordinance 17-O-2899 was an emergency ordinance. Liston moved to suspend the rule requiring an ordinance or resolution be read at two separate meeting dates of council for the purpose of an emergency. Souder seconded the motion and on roll call: Noel, yea; Bekar, yea; Souder, yea; McBane, yea; Liston, yea; and Boggs, yea. (Motion Passed.)

McBane read Ordinance 17-O-2899 by title only-----  
"AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 16-O-2893 TO MAKE TEMPORARY APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF COLUMBIANA, STATE OF OHIO, FOR THE FIRST THREE MONTHS OF THE YEAR 2017 ENDING MARCH 31, 2017."
